The penalty in the case of a first offence is a fine not exceeding \$1,000 or to imprisonment for a term not exceeding 3 months, and in the case of a second or subsequent offence, to a fine not exceeding \$2,000 or to imprisonment for a term not exceeding 6 months.

(b) *I / We understand that the retained and bid number is not transferable. If *I / We *am/are unable to use the retained or bid vehicle registration number after the application has been approved no cancellation will be allowed. The Registrar of Vehicles reserves the right to reassign the number without notice.

(c) *I / We declare that the particulars furnished in this application and other supporting documents are true and correct to the best of *my / our knowledge and belief. I am / We are aware that furnishing any false or misleading particulars or documents in this application is an offence under Section 129 of the Road Traffic Act.
