UNDERTAKING TO ABIDE BY RULES & CONDITIONS FOR EXCLUDED VEHICLES TO USE THE EXPRESSWAY

Section A

This form (consists of Section A, B and C) may take you 5 minutes to complete.

The following conditions shall apply:

1. The application for the permit shall be made at least 3 working days (excluding Saturdays, Sundays and Public Holidays) in advance of the date of intended travel.
2. No excluded vehicle shall at any time enter any expressway tunnel or any tunnel sliproad.
3. No excluded vehicle with permit shall travel on any expressway during peak hours (from 7.00am to 9.30am and from 5.00pm to 9.30pm), unless special authorisation is granted for travel during this period.
4. The height and width of the vehicle/trailer must not exceed 4.50 metres and 2.60 metres respectively.
 - a) If the height exceeds 4.50 metres, the vehicle must be escorted by Auxiliary Police Officers (APOs) while travelling on the roads. Note: Applicants may be required to submit to the Registrar documentary proof that APOs would be engaged to escort the vehicles when they are being used on the expressways during the approval period.
 - b) If the overall width of the motor vehicle/trailer or load exceeds 2.6 metres, application has to be made to:

Note: The approval from RIM is required as a supporting document for this application.
5. The Authority may require the vehicle(s) to be presented for inspection without notice.
6. When travelling on expressway, the permit must be readily available in the vehicle for checks by the Authority at all times.
7. For cement mixer owners/drivers, please ensure that the vehicle does not drip cement on the road, and that all safety devices are engaged before proceeding on the road/expressway.
8. The issuance of the permit is subject to the discretion of the Singapore Registrar of Vehicles. The Registrar of Vehicles may revoke the permit without giving advance notice. Breach of any of the above conditions or the Road Traffic Act or of any other applicable legislation may result in a revocation of the permit.
9. The applicant/applicant company hereby agrees to indemnify the Authority for any losses, damages or claims howsoever caused or sustained as a result of the use of the expressway by the vehicles for which this application is made.
