POWER OF ATTORNEY

This POWER OF ATTORNEY is given on the day <Day> of <Month> <Year> by me <Name of Registered Owner> holder of NRIC/Passport No. <NRIC/Passport No.> of <Country> (if owner is a passport holder) of <Address>.
