

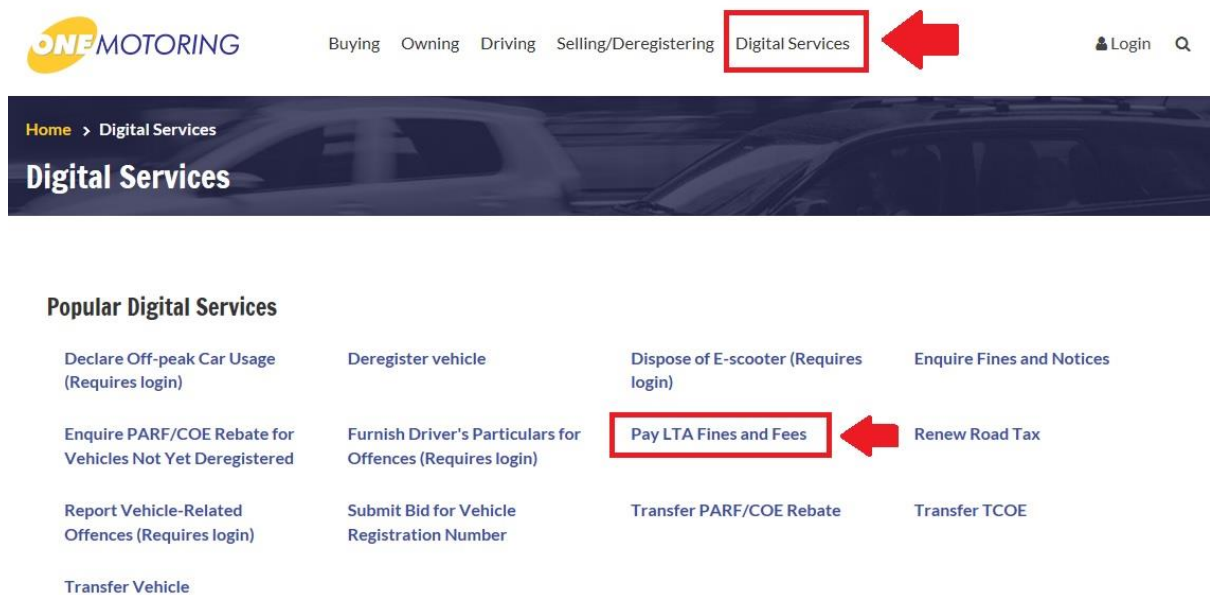
How to renew my vocational licence online via One-Pay-Hub

Please make sure you have fulfilled all the licence renewal requirements (refer to your renewal notice) before you proceed.

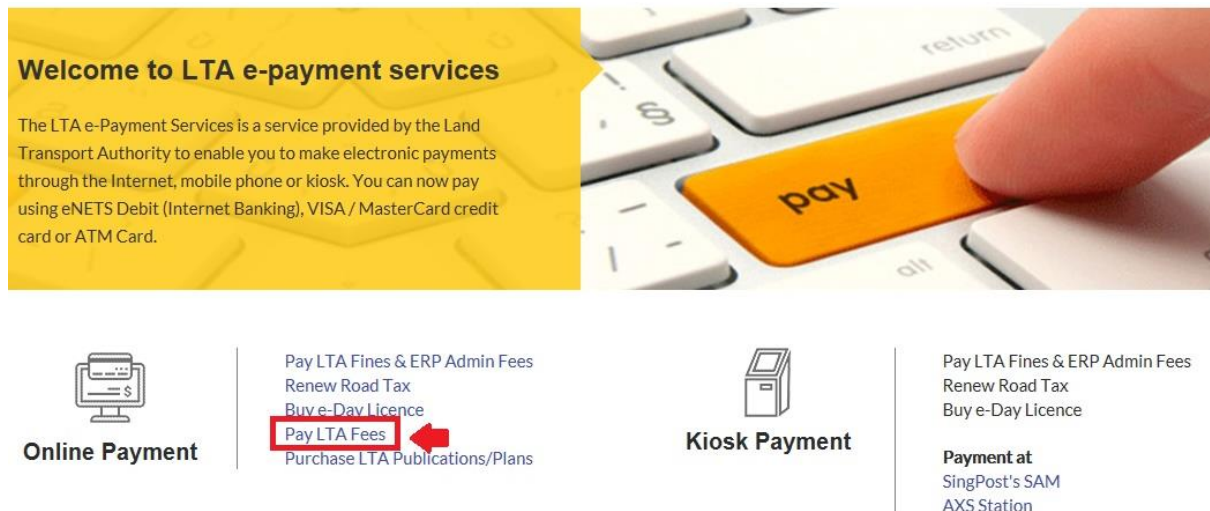
If all the requirements are met, your licence status will be updated in around 3 working days after you make the payment. Check your vocational licence status at One Motoring website > Digital Services > Enquire Vocational Licence Application Status.

Step 1: Visit One Motoring website

(<https://www.onemotoring.com.sg/content/onemotoring/home.html>). Click "Digital Services", then "Pay LTA Fines and Fees".



Step 2: Click "Pay LTA Fees" under Online Payment.



Step 3: Look for **"Vocational Licence Renewal Fee For Active Taxi Drivers (Non-Refundable)"** if you are an active taxi driver. If not, look for **"Vocational Licence Renewal Fee For Other Drivers (Non-Refundable)"**. Then click **"Add"**.
